註釋

- (1)上表的數字乃根據由公營建築工程(指建築署、土木工程拓展署、渠務署、機電工程署、環境保護署、路政署、房屋署及水務署範圍的工程項目)的主要承建商自行填報的行政報表,即「建造工程的地盤工人調配及工資月報表」(GF527)的資料編製而成。因此,該等資料並不能代表建築行業的整體情況,只用以計算公營建築工程工資成本的變動。
- (2)鑑於建造業所採用的一些普遍做法,工資成本的數據可能已包括如服務費、行政費用等成本元素。因此,工資數字未必能反映建造業工人所取得的工資。
- (3)一些職業的每日平均工資可能有較大的按月波動,這 主要是由於這些職業的人力需求較小,每月只有很少 數目(且可能與上月完全不同)的公營建築工程聘請 有關工人所致。
- * 指 2016年 2月的每日平均工資,原因是其後沒有更 新的數字。

Notes

- (1) Figures in the above table are compiled based on the information obtained from the self-administered "Monthly Return of Site Labour Deployment and Wage Rates for Construction Works" (GF527) completed by main contractors in the Public Sector Construction Projects (i.e. construction projects under Department, Civil Engineering Services Department, Electrical the Services Architectural Drainage Development Department, Mechanical Services Department, Environmental Protection Department, Highways Department, Housing Department and Water Supplies Department). Hence, they are not meant to represent the overall situation of the construction Highways Department, industry and are used for deriving the changes in labour costs in Public Sector Construction Projects only.
- (2) In view of some common practices adopted by the construction industry, the wage cost data may have included such elements as service charges, administrative overheads, etc. Hence, the wage rate may not reflect the wage received by the workers in the construction industry.
- (3) The average daily wages of some occupations may be subject to relatively large fluctuations from month to month. This is mainly because the number of workers required for these occupations is relatively small and only a small number of Public Sector Construction Projects (which may be completely different from those in the preceding month) employ such workers each month.
- * Refers to the average daily wage for February 2016 as there is no more up-to-date figure.
