Revision of the Hong Kong Standard Industrial Classification

為使全球各地的統計系統互相協調及可比較,依從官方統計國際標準是重要的。香港已隨「所有經濟活動的國際標準產業分類(國際標準產業分類)修訂本第4版」的最新發展,最近在檢討現行的「香港標準行業分類」(即「香港標準行業分類 1.1 版」)時,把「國際標準產業分類修訂本第4版」內概念上和結構上的改變一併納入「香港標準行業分類 2.0 版」。在製訂「香港標準行業分類 2.0 版」時,香港經濟結構的重大變化和新興經濟活動的出現都已列入考慮範圍。

政府統計處將會由二零零九年起在不同統計調查相繼採用「香港標準行業分類 2.0 版」。

本文描述「香港標準行業分類 2.0 版」的發展及實施,尤其強調由「香港標準行業分類 1.1 版」發展為「香港標準行業分類 2.0 版」所涉及的轉變,即分類制度結構的變化、提高與國際銜接程度的變化,以及更切合本地使用者需求的變化。

It is important to comply with international standards in official statistics so as to achieve harmonisation and comparability in the global context. In keeping abreast of the latest developments of the International Standard Industrial Classification of All Economic Activities Revision 4 (ISIC Rev. 4), Hong Kong has recently incorporated the conceptual and structural changes of ISIC Rev. 4 into Hong Kong Standard Industrial Classification Version 2.0 (HSIC V2.0) when reviewing the existing HSIC, i.e. HSIC V1.1. Significant changes in the structure of the Hong Kong economy and the emergence of new economic activities have been taken into account when devising HSIC V2.0.

HSIC V2.0 will be adopted in various surveys of the Census and Statistics Department progressively starting from 2009.

This article describes the development and implementation of HSIC V2.0, with particular highlights on the changes from the HSIC V1.1 to HSIC V2.0, namely, changes in structure of classification scheme, changes for enhancing international comparability, and changes initiated by Hong Kong to better meet the requirements of local users.

修訂「香港標準行業分類」

Revision of the Hong Kong Standard Industrial Classification

1. 引言

- 1.1 政府統計處編訂及備存「香港標準行業 分類」,以此作為統計分類架構,藉以根據 主要經濟活動,把經濟單位以行業分類。這 個分類架構不僅在不同的統計調查為香港經 濟單位的抽樣作基本分層,也是用以編製、 分析和發布按經濟活動劃分的統計數字的標 準行業分類。
- 1.2 「香港標準行業分類」以聯合國的「所有經濟活動的國際標準產業分類(國際標準產業分類)修訂本第 2 版」(英文簡稱 ISIC Rev. 2)為藍本,配合本地的情況作出修訂,其第一版於一九九零年開始推行。統計處就「香港標準行業分類」不時予以檢討,以反映香港經濟結構的重大變化和新興的經濟活動。「香港標準行業分類 1.1 版」是一重要的更新版本,於二零零一年推行。
- 於二零零八年,統計處已經完成「香港 標準行業分類」的全面檢討工作,旨在令該 分類系統達致所需的相關性、可比性及銜接 性。已修訂的「香港標準行業分類」(即 「香港標準行業分類 2.0 版」)採用「所有經 濟活動的國際標準產業分類(國際標準產業分 類)修訂本第 4 版」的基本分類架構和歸類原 則,以及結構和概念的轉變,該產業分類系 統已由聯合國統計司於二零零八年八月正式 公布。在修訂「香港標準行業分類」和編纂 「香港標準行業分類 2.0 版」的過程中,統計 處不僅進行內部諮詢,並向外界諮詢,廣邀 政府各局/部門、公共機構、商會和業界組 織、學術界和特定行業內具領導地位的機構 等發表意見。從各方收集的意見已盡可能納 入「香港標準行業分類 2.0 版」之內。

1. Introduction

- 1.1 The Census and Statistics Department (C&SD) devises and maintains the Hong Kong Standard Industrial Classification (HSIC) as a statistical classification framework for classifying economic units into industry classes based on their major activities. This framework not only provides a basic stratification for sample selection of economic units in various surveys, but also serves as a standard industrial classification in Hong Kong for compilation, analysis and dissemination of statistics by economic activity.
- 1.2 The HSIC is modelled on the United Nations' International Standard Industrial Classification of All Economic Activities Revision 2 (ISIC Rev. 2) with local adaptation and its first version (V1.0) was introduced in 1990. The HSIC has been reviewed from time to time to reflect significant changes in the industrial structure of the Hong Kong economy and the emergence of new economic activities. A revised version, HSIC V1.1, which represented a more significant round of update, was implemented in 2001.
- A full-scale revision exercise on the HSIC aiming to achieve relevance, comparability and continuity has been completed in 2008. The revised HSIC, i.e. HSIC V2.0, adopts the basic framework and principles, as well as the structural and conceptual changes of the International Standard Industrial Classification of All Economic Activities Revision 4 (ISIC Rev. 4), which was released officially by the United Nations Statistics Division (UNSD) in August 2008. During the revision of HSIC and development of HSIC V2.0, consultation had been conducted not only within C&SD but also externally covering all government bureaux/ departments, public organisations, chambers of commerce, trade associations, academic institutions and leading companies in specific industries. Comments of such wide cross-section of stakeholders have been incorporated into HSIC V2.0 as far as possible.

1.4 統計處不同的統計調查將會由二零零九年起相繼採用「香港標準行業分類 2.0 版」。「香港標準行業分類 1.1 版」與「香港標準行業分類 2.0 版」之間的變化可分為三個方面:分類制度結構的變化、提高與國際銜接程度的變化,以及更切合本地使用者需求的變化。

2. 分類制度結構的變化

- 2.1 「香港標準行業分類 2.0 版」是把「香港標準行業分類 1.1 版」作適當調整,再銜接已推行的「國際標準產業分類修訂本第 4版」編製而成。主要的結構變化如下:
- (a) 「香港標準行業分類 1.1 版」的基本結構由四層擴展至「香港標準行業分類 2.0 版」的五層分級結構。
- (b) 高層次分組的數目由「香港標準行業分類 1.1 版」的九個(以個位數值表示,即由 1 至 9)增至「香港標準行業分類 2.0 版」的二 一個(以一個英文字母表示,即由 A 至 U)。該等分組的涵蓋範圍與「國際標準產業分類修訂本第 4 版」的二 一個高層次的分組大致相若。「香港標準行業分類 1.1 版」及「香港標準行業分類 2.0 版」的高層次分類的概略比較載於**附件**。
- (c) 「香港標準行業分類 2.0 版」最細緻的 分類層次共有 1000 個六位數字的編 碼,相比之下,「香港標準行業分類 1.1 版」只有 886 個六位數字的編碼。
- 2.2 「香港標準行業分類 2.0 版」的兩位數字分類代表本地最重要的行業類別,並與「國際標準產業分類修訂本第 4 版」的行業類別大致相若。這種對照性遵照聯合國統計司的建議,以維持「國際標準產業分類修訂本第 4 版」第二層次的一致性。此外,「香港標準行業分類 2.0 版」的第三和第四層次(即第三位和第四位數字)可與「國際標準產業分類修訂本第 4 版」達致高度一致性。

1.4 HSIC V2.0 will be adopted by various surveys of C&SD progressively starting from 2009. The changes from HSIC V1.1 to HSIC V2.0 can be viewed as comprising three elements: changes in structure of classification scheme, changes for enhancing international comparability and changes initiated by Hong Kong to better meet the requirements of local users.

2. Changes in Structure of Classification Scheme

- 2.1 HSIC V2.0 is developed by adjusting the HSIC V1.1 with convergence to the ISIC Rev. 4. Major changes in structure are as follows:
- (a) The general structure of HSIC V1.1 has been changed from a 4-level to a 5-level hierarchical system when revised to HSIC V2.0.
- (b) The number of top level groups has been increased from 9 in HSIC V1.1 (represented by 1-digit numeral, i.e. 1 to 9) to 21 in HSIC V2.0 (represented by 1 alphabet, i.e. A to U). They are compatible with the coverage of the 21 top level groups of the ISIC Rev. 4. A crude conversion between the top level classifications of HSIC V1.1 and HSIC V2.0 is given in the **Annex**.
- (c) There are altogether 1 000 6-digit codes at the most detailed level of HSIC V2.0, compared with 886 6-digit codes in HSIC V1.1.
- 2.2 The two-digit categories of HSIC V2.0 represent the most important local industry sectors and are compatible with those of ISIC Rev. 4. This compatibility serves to follow the recommendation of the UNSD on maintaining compliance at level 2 of ISIC Rev. 4. Furthermore, high degree of conformance is achieved for the third and fourth levels (i.e. 3- and 4-digit) in HSIC V2.0.

- 2.3 「香港標準行業分類 2.0 版」的六位數字編碼屬於第五層次,該層次的編碼是為配合本地的分類需要。當中有不少已在「香港標準行業分類 1.1 版」有六位數字的編碼,以維持連續性。此外,亦加入不少新行業的六位數字編碼及目前已變得重要但之前卻和其他行業合併而歸入一個較廣的行業編碼內(例如歸入多個行業類別中的雜項或餘下活動的編碼)的六位數字編碼。「香港標準行業分類 2.0 版」和「國際標準產業分類修訂本第 4 版」的結構及編碼系統,簡述如下:
- 2.3 Six-digit codes of HSIC V2.0, constituting its fifth level, are defined to meet local classification needs. Many of them have their 6-digit counterparts in HSIC V1.1 in order to preserve continuity. Besides, a number of new 6-digit codes are introduced for new industries as well as for the existing ones which have become significant but have previously been subsumed under a broader industry code with other industries (e.g. under those miscellaneous or residual activities codes in various sectors). The structures and numbering systems of HSIC V1.1, HSIC V2.0 and ISIC Rev. 4 are summarised below:

3. 提高與國際銜接程度的變化

- 3.1 由於很多經濟體系已努力調整本身的分類系統,以致所匯報的數據能符合「國際標準產業分類修訂本第 4 版」的分類要求,最少也符合兩位數字層次的要求,因此,與「國際標準產業分類修訂本第 4 版」互相銜接的「香港標準行業分類 2.0 版」可作進行國際性資料比較的必需工具。「香港標準行業分類 2.0 版」的推行會令香港與這個主要的國際發展一致,並利便本地及海外用戶使用官方統計數字。
- 3.2 此外,在分類系統的較高層次加入一些新的分組,例如"資訊及通訊"的行業,有助提高所處理資料的適切程度。另一方面,有些「香港標準行業分類 1.1 版」的現存行業將予以更詳細描述,部分類別更會提升至較高的層次,例如"廢棄物管理活動"、"專業、科學及技術活動"和"地產活動"。以上各項皆有助更貼切地與國際標準作出比較。以下是經參考「國際標準產業分類修訂本第 4 版」以確保國際可比性的主要變化:
- (a) 增設整合所有與環境有關的活動的高層 次分組,名為"自來水供應;污水處 理、廢棄物管理及污染防治活動"。
- (b) 另一個新的高層次分組是"資訊及通 訊"。資訊活動的特色是包含知識創造 力及其包含產品通常受到版權保護。這 類活動和相關的內容傳遞服務屬於香港 經濟體系內急速增長的行業類別,當中 包括以下各項列入「香港標準行業分類 1.1 版」的不同行業類別:
 - ▶ 包括軟件出版的活動;
 - 電影、錄像及電視節目製作、錄音 及音樂出版活動;

3. Changes for Enhancing International Comparability

- 3.1 Aligning with ISIC Rev. 4, HSIC V2.0 provides an essential tool for international data comparison as many economies have been making efforts to adjust their own classifications in such a way that data can be presented according to the categories of ISIC Rev. 4, at least at the 2-digit level. The implementation of HSIC V2.0 will bring Hong Kong compatible with this major international development and facilitate local and overseas users in using the official statistics.
- 3.2 Moreover, data relevance is enhanced through the introduction of a number of new groups at higher levels of the classification, such as the "Information and communications" industry. On the other hand, some existing industries in HSIC V1.1 are described in more detail and some categories are elevated to higher levels, such as "Waste management activities", "Professional, scientific and technical activities" and "Real estate activities". All these will allow for much better comparison with international standards. Below are the major changes aiming at ensuring international comparability making reference to ISIC Rev. 4:
- (a) A top level group consolidating all environment-related activities is created, namely, "Water supply; sewerage, waste management and remediation activities".
- (b) There is another new top level group "Information and communications". Information activities are characterised by the involvement of intellectual creativity and the products involved are usually protected by copyright. Such activities and the related content transmitting services have been identified as a rapidly growing sector in the Hong Kong economy. They encompass the following which are classified in different sectors in HSIC V1.1:
 - ➤ Publishing activities including software publishing;
 - Motion picture, video and television programme production, sound recording and music publishing activities;

- ▶ 節目編製及廣播活動;
- ▶ 電訊;
- ▶ 資訊科技服務活動;以及
- 包括新聞通訊社的其他資訊服務活動。
- (c) 為了更貼切地反映服務的多樣性,「香港標準行業分類 1.1 版」內的"金融、保險、地產及商用服務業"會在「香港標準行業分類 2.0 版」內分為以下四個高層次的分組:
 - ▶ 金融及保險活動;
 - ▶ 地產活動:
 - ▶ 專業、科學及技術活動;以及
 - ➢ 行政及支援服務活動。
- (d) 同樣地,「香港標準行業分類 1.1 版」 內的另一行業類別"社區、社會及個人 服務業"也會在「香港標準行業分類 2.0 版」內分為以下七個高層次的分組:
 - ▶ 公共行政;
 - 教育;
 - ▶ 人類保健及社會工作活動;
 - 藝術、娛樂及康樂活動;
 - 其他服務活動;
 - ▶ 家庭住戶內部工作活動;以及
 - 享有治外法權的組織及團體活動。

- Programming and broadcasting activities;
- > Telecommunications;
- > Information technology service activities; and
- ➤ Other information service activities including news agencies.
- (c) To better reflect the variety of services, the sector "Financing, insurance, real estate and business services" in HSIC V1.1 is divided into four top level groups in HSIC V2.0, namely:
 - > Financial and insurance activities;
 - > Real estate activities;
 - Professional, scientific and technical activities; and
 - Administrative and support service activities.
- (d) Similarly, another sector "Community, social and personal services" in HSIC V1.1 is divided into seven top level groups in HSIC V2.0, namely:
 - > Public administration;
 - **Education**;
 - > Human health and social work activities;
 - > Arts, entertainment and recreation;
 - > Other service activities;
 - Work activities within domestic households; and
 - ➤ Activities of extraterritorial organisations and bodies.

4. 更切合本地需求的變化

- 4.1 上文第 2.3 段提及「香港標準行業分類 2.0 版」較「國際標準產業分類修訂本第 4 版」多一個層次。「香港標準行業分類 2.0 版」的第五個層次納入對香港經濟重要的細緻行業。因應普遍需要而分別識認新興的金融、商用和個人服務行業,經修訂後「香港標準行業分類」的結構較前版本更詳盡。另一方面,反映香港經濟在過去數年所經歷的重大結構轉移情況,製造業的詳盡行業分類數目也減少。其中一些因應本地情況而作出主要修訂的顯著地方如下:
- "進出口貿易"在「國際標準產業分類修 (a) 訂本第 4 版」沒有撥作獨立的分組,但 在「香港標準行業分類」則屬於第二層 次的分組。這個組別在「香港標準行業 分類 2.0 版」再細分為兩個第三層次的 分組,即"進口批發"和"出口貿易"。把 "進口批發"與「香港標準行業分類 2.0 版」內其他行業分開,尤其有用(「香 港標準行業分類 1.1 版」內的"進口批 發"不能被獨立分出來),原因是"進口批 發"可與另外的第二層次分組"批發"結 合,以提供一個供進行本地批發活動研 究的理想框架。進出口貿易、批發及零 售業在「香港標準行業分類」1.1 版和 2.0 版的高層次分類系統的比較如下:

4. Changes Initiated by Hong Kong to Better Meet Local Requirements

- 4.1 As described in paragraph 2.3 above, HSIC V2.0 has one more level than ISIC Rev. 4. Its level 5 is to accommodate refined industries which are significant in the local economy. Responding to the general need to identify the emerging financial, business and personal service industries separately, the structure of the revised HSIC is more detailed than that of the HSIC V1.1. On the other hand, there is reduction in the number of detailed manufacturing industries as a reflection of the significant structural economic shift experienced by the Hong Kong economy over the years. Some major adjustments for local adaptation are highlighted below:
- "Import/Export" is a group not found in ISIC (a) Rev. 4 but a level 2 group in HSIC. It is further divided into two level 3 groups, namely, "Import for wholesale" and "Export trade" in HSIC V2.0. The separation of "Import for wholesale" from other industries in HSIC V2.0 (which cannot be singled out in HSIC V1.1) is in particular useful since it can be combined with another level 2 group "Wholesale" to provide a good framework for studies on domestic wholesaling activities. Below is a comparison between the high level classification schemes of HSIC V1.1 and V2.0 for the import/export, wholesale and retail trades.

(b) 「香港標準行業分類 1.1 版」以單一的編碼代表中式酒樓,再以另一單一編碼代表非中式酒樓。「香港標準行業分類 2.0 版」則增設獨立的編碼代表港式茶餐廳和粵式酒樓菜館;京、川、滬式酒樓菜館;及供應其他中菜的中式酒樓菜館。其他食肆也按菜式分為泰式、越式、法式等。香港是美食之都,這樣的分類有助深入研究香港的膳食服務行業。

(b) In HSIC V1.1, there is only one single code for Chinese restaurants and another single code for non-Chinese restaurants. In HSIC V2.0, separate codes for Hong Kong style tea cafes and Guangdong cuisine restaurants; Beijing, Sichuan, Shanghai cuisine restaurants; and Chinese restaurants serving other Chinese cuisine are created. Other restaurants are further divided into Thai, Vietnamese, French, etc. This will facilitate future studies on the food service industries in Hong Kong which is well-known as a culinary capital.

- (c) 在「香港標準行業分類」從 1.1 版修訂 為 2.0 版的過程中,"社區、社會及個人 服務業"的行業類別在不同較低層次的 分組加入更詳細的分類。此舉反映這個 行業類別正在變化和日益重要。「香港 標準行業分類 1.1 版」的最詳細分類層 次中許多編碼均在「香港標準行業分類 2.0 版」中予以保留,另外又深入研究 某些第三或第四層次的編碼可否進一步 拆分為第五層次的編碼,特別是教育服 務、娛樂及康樂服務,以及個人服務的 雜項或其餘活動的編碼,目前普遍認為 在提供分析及迎合用戶需要的層面上過 於廣泛。在這方面被獨立分出來作第五 層次編碼的服務的例子有"瑜伽及健身 訓練"、"體重控制及纖體服務",以及 "足底按摩"。
- (d) 通過把一些低層次的行業分組合併,在 "製造業"內最細緻層次的六位數字編碼 的總數由「香港標準行業分類 1.1 版」 的 372 個減少至「香港標準行業分類 2.0 版」的 244 個。舉例來說,"機械鐘 錶製造業"不再細分為四個小分類,即 "機械鐘的製造"、"機械錶的製造"、"機 械鐘肉的製造"和"機械錶肉的製造", "電子鐘錶製造業"的處理方法也相同。 編碼數目的減少,反映製造業的後勤辦 公室服務和後勤支援雖然仍然設於香 港,但大部分製造工序已遷往中國內 地。

5. 推行「香港標準行業分類 **2.0** 版 」

5.1 隨着聯合國統計司在二零零八年八月正式公布「國際標準產業分類修訂本第 4 版」後,統計處亦已於二零零八年 月三 一日正式推行「香港標準行業分類 2.0 版」。

- In revising HSIC from V1.1 to V2.0, more (c) details have been introduced in the sector "Community, social and personal services" at different lower levels. Such a move reflects that this is a sector of change and variety with growing importance. While many codes at the most detailed level in HSIC V1.1 are to be kept in HSIC V2.0, efforts have been made to study whether some level 3 or 4 codes could be further split into level 5 codes, particularly for those miscellaneous or residual activities codes education services. amusement and recreational services, and personal services, which are all considered too broad nowadays for analytical purposes and meeting users' needs. Examples on services singled out as level 5 codes in this regard are "Yoga and gymnastics instruction", "Weight control and slimming services" and "Foot reflexology".
- (d) The total number of 6-digit codes at the most detailed level of the "manufacturing sector" is, however, reduced from 372 in HSIC V1.1 to 244 in HSIC V2.0 through merging a number of low level industry groups. For example, "Watches mechanical, and clocks, manufacturing" is no longer divided into the four sub-categories "Clocks, mechanical, manufacturing", "Watches, mechanical. manufacturing", "Clock movements, mechanical, manufacturing" and "Watch movements, mechanical, manufacturing", and similarly for "Watches and clocks, electronic, manufacturing". The drop in the number of codes aligns with the fact that manufacturing operations have largely been relocated to the mainland of China although the back-office service and logistics support are still available in Hong Kong.

5. Implementation of HSIC V2.0

5.1 With the official release of ISIC Rev. 4 by UNSD in August 2008, HSIC V2.0 was officially launched on 31.10.2008.

- 5.2 統計處推行「香港標準行業分類 2.0 版」,即表示現備存於機構單位記錄庫內關於機構單位的所有香港標準行業分類編碼須要轉化作銜接。為確保在推行「香港標準行業分類 2.0 版」時,銜接性得以維持,提供並行編碼非常重要,即「香港標準行業分類」 1.1 版和 2.0 版的編碼,以提供一個完整基礎,使多種統計活動的銜接性得以保存。因此,機構單位記錄庫於二零零八年及二零零九年均進行並行編碼的工序。
- 5.3 此外,由於統計處的不同統計調查將會 於二零零九年起相繼採用「香港標準行業分 類 2.0 版」,因此所有經濟及社會統計調查系 統必須作出改動以配合有關轉變,並在由重 新設計抽樣計劃至發布統計數字的一系列活 動中採用已修訂的「香港標準行業分類」編 碼。相關電腦系統亦因此須作出改動。為了 盡可能達到統計數列的穩定性及銜接性,過 去的統計數字亦須根據「香港標準行業分類 2.0 版」而重新編製。
- 5.4 從生產面計算的本地生產總值,主要是根據以不同行業為調查對象的「按年經濟統計調查系列」的資料而編製。引入「香港標準行業分類 2.0 版」劃分的二零零九年的按年經濟統計調查系列的結果,將會在二零一零年年底發布,而過去的數列亦將會根據「香港標準行業分類 2.0 版」重新編製。因此,以「香港標準行業分類 2.0 版」重新編製。因此,以「香港標準行業分類 2.0 版」按經濟活動劃分的二零零九年及之前的本地生產總值可於二零一一年發布。
- 5.5 「香港標準行業分類 2.0 版」的詳細資料載於《香港標準行業分類 2.0 版》手冊內,該手冊載有 2.0 版的序言、編碼及名稱索引,以及詳細結構和簡介。用戶可於統計處網站(www.censtatd.gov.hk/products_services/products/publications/classification_lists/index_tc_cd_B2XX000401C_dt_detail.jsp)免費下載該手冊(PDF格式)。

- 5.2 Implementation of HSIC V2.0 in C&SD means that all the HSIC codes of the establishments currently kept in the Central Register of Establishments (CRE) have to be converted. To ensure that continuity can be maintained in implementing HSIC V2.0, it is also important to provide parallel codes, i.e. codes with both HSIC V1.1 and HSIC V2.0, so that a sound basis to allow continuity in various statistical activities can be formed. As such, the CRE is now undergoing parallel coding for 2008 and 2009.
- 5.3 Besides, as various surveys of C&SD will adopt the HSIC V2.0 progressively starting from 2009, all economic and social survey systems are required to be modified to dovetail with the changes and adopt the revised HSIC codes in activities ranging from redesign of sampling scheme to publication of statistics. The respective computer systems have to be modified accordingly. Stability and continuity of statistics of the data series have to be achieved as far as possible, and thus recompilation of past statistics according to HSIC V2.0 is also required.
- 5.4 The introduction of HSIC V2.0 will also affect the compilation of the production based Gross Domestic Product (GDP), which is based mainly on inputs from the Programme of Annual Economic Surveys (PAES) targeted at different industry sectors. The results of the PAES in HSIC V2.0 for 2009 will be released in late 2010 and backdated series will also be compiled. Accordingly, the GDP in HSIC V2.0 for 2009 and before will be made available in 2011.
- 5.5 Detailed information on HSIC V2.0 is given in the manual *Hong Kong Standard Industrial Classification (HSIC) Version 2.0*, which contains the preface, index of codes and titles for HSIC V2.0, and detailed structure and explanatory notes. Users can download this manual (in PDF format) free of charge from the website of C&SD (www.censtatd.gov.hk/products_and_services/products/publications/classification_lists/index_cd_B2XX000401E_dt_detail.jsp).

- 5.6 由於資料搜集和統計數字的表述已沿用「香港標準行業分類 1.1 版」多年,因此有必要編訂「香港標準行業分類 1.1 版」與「香港標準行業分類 2.0 版」的對照表,以詳細說明在修訂過程中出現的變化情況。「香港標準行業分類 2.0 版」與「香港標準行業分類 1.1 版」的詳細對照表全文快將上載至統計處網站。
- 5.7 統計處網站亦將會設有供查核「香港標準行業分類 2.0 版」資料的搜尋工具。除可按照「香港標準行業分類 2.0 版」的編碼搜尋資料外,搜尋工具亦可讓用戶在編碼範例及編碼名稱和內文中進行搜尋。此外,統計處網站亦將提供顯示「香港標準行業分類 2.0 版」完整架構的功能,用戶可使用該功能輕易掌握「香港標準行業分類 2.0 版」的詳細結構。

6. 日後的更新工作

6.1 統計處會就「香港標準行業分類 2.0 版」不時予以檢討,以反映本地經濟呈現的重大變化。統計處會參考「國際標準產業分類」及有關人士的意見,使「香港標準行業分類」的經修訂架構能反映其對現時全球經濟活動的適切性;達到可與國際及其他統計經濟體系的統計可比性,以及維持與過去的數列的銜接性。

- 5.6 Since HSIC V1.1 has been used for collection and presentation of statistics in many areas for years, there is a strong need for concordance tables between HSIC V2.0 and HSIC V1.1 to reveal the detailed changes that have taken place in the revision process. Complete detailed concordances between HSIC V2.0 and HSIC V1.1 will be made available on the website of C&SD shortly.
- 5.7 A search tool for checking HSIC V2.0 information will also be made available on the website of C&SD. Apart from searching based on HSIC V2.0 codes, the tool also allows users to search among code examples as well as among code titles and explanatory text. In addition, a function for displaying a full hierarchy of HSIC V2.0 will be provided through which users can grasp the detailed structure of HSIC V2.0 easily.

6. Future Updating

6.1 HSIC V2.0 will be reviewed from time to time to reflect the significant changes in the local economy. References will be made to ISIC as well as views of stakeholders so that the revised framework of HSIC is able to reflect relevance to the current global economic activities, achieve comparability of statistics from international and other statistical economies, and maintain continuity with historical data series.






